Academic researcher of Congress, institutional reform, with an upcoming book on congressional earmarking with Oxford University Press. Founder and Co-Director of the Policy Lab, a model for experiential undergraduate policy research linking students, scholars, and policymakers. Undergraduate Summer Research Fellows Program

Each summer since 2020, I have directed an 8-week fellowship program supervising a team of undergraduates working part-time on my academic and policy research. Fellows receive structured training in data science, policy analysis, and applied political research, and contribute to ongoing projects in congressional reform, election law, earmarks, and access to justice:

- 2020: Creating survey instruments and interviewing former Members of Congress regarding their career experience with earmarking.
- 2021: Evaluating state election emergency laws and disrupted elections during COVID.
- 2022: Evaluating county-level turnout and access to voting in the 2020 federal elections.
- 2023: Classifying earmarking journalism with dictionary methods.
- 2024: Content analysis of earmarking journalism using LLMs.
- 2025: Using High Performance Computing to assess changes to state-level voting access laws using voter administrative data.
